

Local Public Health Unit Regulatory Jurisdiction Areas by License Type

To determine the licensing and inspection regulatory authority for facilities in North Dakota, first determine the physical location of the establishment and then the license type. If the corresponding space does not have an "X" or the location is not listed in the "Areas Covered" column, then this license is under the regulatory jurisdiction of the ND Department of Health Division of Food and Lodging.
